National guidelines – United States of America (Texas)

In order to comply with national requirements we are implementing the following further precautionary measures:

Travel	No employees or delegates must enter RelyOn Nutec-Houston facilities for 14 days upon		
	return who currently have/ previously had any Corona-like symptoms within the last 48		
	hours or the individual is aware that they have had any contact with a person infected or		
	suspected to be infected with Coronavirus.		
Quarantine	If any of our employees'/ delegates co-habitants, such as spouse and children, are		
	placed in quarantine by the authorities, irrespective of the reason or background, who		
	currently have/ previously had any Corona-like symptoms within the last 48 hours or the		
	individual is aware that they have had any contact with a person infected, or suspected to		
	be infected with Coronavirus, the relevant employee/ delegate must also be quarantined		
	from RelyOn Nutec locations for the same period or a minimum of 14 days.		
Social	We are complying with the state guidance on keeping social distance to the extent		
distancing	possible between employees and public, employees shall wear face coverings at all		
	times if interacting with the public. Waiting rooms, lobbies or other areas where members		
	of the public may congregate, excluding bathrooms, shall be closed to the public.		
	Members of the public should be required to wait outside or their particular classroom,		
	while maintain social distancing.		
Food	Served is prepared at a restaurant and brought in separate containers to the facility.		
hygiene			
Class sizes	Classes have been reduced to 75% maximum occupancy per classroom, provided the 6		
	feet social distance can be maintained. Otherwise, a reduced number of delegates will be		
	required in order to maintain the 6 feet distancing. Alternatively we may provide		
	theoretical teaching through webinars for selected courses.		
Restrictions	First Aid practical courses are met by video demonstration and chest compressions. No		
on courses/	mouth to mouth will be conducted and the mannequin used shall be sanitized between		
methodology	each use. In-water exercises that require close contact have been eliminated/ modified		
/ equipment	as individual demonstrations while maintaining social distancing to the extent possible.		
	The number of delegates in the METS has been reduced to 50% capacity with social		
	distancing to the extent possible. Learning outcomes that cannot be demonstrated are		
	met by employee explanation/ demonstration and/ or video demonstration.		
Cleaning of	We are complying with the national guidelines and the guidelines from the manufacture		
equipment	to ensure all equipment is properly sanitized and free of pathogens.		
Other	We are complying with the national guidance on keeping 6 feet social distance and the		
national	state's reopening to a maximum number of people gathering as 75% of maximum		
specific	occupancy. Sanitization and hand cleaning products are readily available to both		
guidelines	employees and delegates. Masks can be worn during theoretical and any non in-water		
	practical, should the employee/ delegate choose to do so, provided it does not interfere		
	with their ability to perform demonstrations/ occupational tasks.

Potential
Exposure

If an individual who has been to our facilities is symptomatic, believes they may have come in contact with an infected person, or test positive to have COVID-19, the Director will coordinate with Facility Managers and Sales department to notify all personnel of the potential exposure incident. This includes anyone who may have been exposed up to 48 hours prior to the individual showing any signs or symptoms.
